Kurtis Carolina Show Ski Team will be rejoining the southern region. Garry Stout reports Gulf Coast Skimmers. County owns the club and has hired a director to run the club has potential to be a National site. Team in Alabama doing ski shows. Trying to get them more involved. New club in Ocala FL next weekend (date) barefoot tournament.

Wisconsin- Report submitted and read by Cathy Luiting. Beaverland Must Skis – 25-26th RAJ Mercury invitational. June 25 Mississippi Blackhawks- tournament cancelled. 26 learn to ski, 700 new skiers, 3 disabled skiers clinic. Mad City team had learn to ski program.

Wis State 17-20th 03 26 teams competed. 2 teams did not qualify but were able to ski as exhibition. 28 projected for 04 17-18 of July 04. 6 jump teams for jump team competition.

COMMITTEE REPORTS:

Rules – Sherm Shraft Committee report presented as motion

2nd by – Doug Schwenk.

Discussion ensued. Pete Bonert – Might want to pull some things out of the safety manual specific to NSSA. Some concern about the safety manual being part of the rules then changes would have to go through the rules committee. All changes are approved by the board currently so it would not present any problems. Kurtis recommends highlighting NSSA sections of safety committee.

Call for the question by Schwenk Passed

Paragraph 2.03 as presented 2nd by Bruce carried by board

Rule change 6.04 as presented 2nd by Cathy Luiting

Discussion- Sherm with additional 9 pages of forms for ski club fact sheet. How many will want to fill out the additional reports. 99% of teams are good about filling out the paperwork. Skip- why should this be a rule because rules require assessment of penalties. Terry says we (NSSA) and USAWS need the proper tools to put on a good production. Making it a rule will

require clubs to turn in their paperwork. Failure to comply will result in disqualification. If Optional is removed, clubs will do it. Requirements for documents must be on web site. Cathy talks about the importance of show skiing.

Friendly Amendment- (agreed by Rules Committee chair and Cathy Luiting) "to indicate this is not part of the judges forms and is for TV production only". Place on the form as to why it is being done. General descriptions on what is being done. Terry said she has made it as generic as possible. This will help the commentator interview what is best for the production. Skip mentions that if the club is fined or thrown out of the tournament, would clubs have a problem with this.

Tom makes suggestion to place the following wording on the top of the form "Information on this form is for TV production only and will not be used or considered for judging"

Pete Bonert- It has never been placed in the minutes that failure to meet the requirement of following paperwork that it be a fine only

Motion by Bruce McCalmon -To make failure to complete and submit the tournament required forms be assessed a fine of 50% of tournament entry fee. 2nd by Cathy Luiting.

Discussion: Much discussion about the monetary fines. Motion Carried 13 Yes

Two Opposed.

Tom directs rules committee to review rules and address questions of rules clarification.

Sherm indicates review of Rule 6.05 and insert an exemption to rule 6.04 Garry Stout suggest this be addressed by Rules Committee. Table this until after lunch.

Individual show acts to include 750 buoy 2nd by Schwenk

Discussion: Why are we worried about this for individual acts. This could be used any individual act competition

Passed by Board

Garry Stout: rule 2.03 is in both shows and individual acts. Recommends eliminating duplicating numbers. Gerry Luiting recommends placing a letter in front of the rule to indicate whether it is Show or Individual competition rules.

Awards- Gerry Luiting presents a report. Honorary National Director Sherm Schraft, Terry Pasterski, JR Wilson, Garry Stout, and Jim Lauzon (absent) were presented with plaques and a plaque was made to be displayed at HQ. Sponsor is anonymous. Sherm suggests increasing the size of the Skip Gilkerson and Willa Cook award plaque at HQ or rearranging the names on the plaques.

Grants: Cam McNeil submitted a report of grants submitted, amounts requested, and amounts paid. Preliminary Report. Final report to be presented at Think Tank. Received requests for \$25,000 for membership and 453.00 for safety. 3 regional tournaments Division 2 Nationals Not getting type of requests we would like.

Need to identify teams that need help surviving. Need to get funding for teams to go to think tank. Membership numbers gains are not what we would like to see. Wisconsin does a good job of learn to ski. If you do the \$100 learn to ski programs HQ does not get all the names. Need to focus on growth rather than funding tournaments. Goal is 5% growth per year. Need a form so that HQ can get participant info from Learn to Ski programs.

Nominating:- Barb Taugner- only 177 votes cast out of 700 potential voters. Committee was addressing issue of eligibility of Honorary National Director.

Discussion regarding the qualification for Honorary **National** Director. Exemplary service to NSSA on a national level. The nominating committee can present a number of nominations but can only approve one.

The Nominating committee presents Bob Marx 2nd Doug Schwenk.

Terry Pasterski: Suggested that the Awards for HND be presented the same time each year Cathy Luiting recommends doing it at Think Tank.

NSSA Board Officers to be elected in 2004

Procedures were presented by the Officials Subcommittee to address these issues in the form of a motion.

2nd by McCalmon-

Discussion:

Objective to enable the Official's Committee and NSSA Board to properly take corrective action in the event of an officials poor performance and must have:

Clear definition of what constitutes poor performance, Set Procedures for handling performance problems, Communication of these procedures to all officials, Consistent and impartial enforcement of the procedures.

Performance issue was addressed previously but no procedure was in place to handle such issues. Roger wants to know where this will be placed (rules or P&P)

Garry Stout questions definitions of performance are not clear. Believes these definitions are too vague. The intent was to make judges accountable for their performance. Unsportsmanlike conduct is in our rules currently. Performance will be determined by the scoring charts as erratic or flat lined. Conflicts of interest real or perceived.

Carried unanimously.

Motion by Bruce McCalmon this document be placed in Policies and Procedures manual if the P&P manual is approved. If P&P is not approved, this should go in officials manual and add a mailing to all officials. 2nd by Schwenk,

Discussion: Teams need to have access to this document. Perhaps place this on the website.

Motion by Hayes that tested driver candidates are to meet minimum age meet state requirements for operating a boat 2nd by Olson. Carried.

Examiner- recommend participate in 4 clinics instead of 3 to become an examiner. This is intended to become effective **immediately** 4th clinic they are examiner and will be graded on for proficiency. Must have a class 3 rating. 2nd by Bud Ruhl passed.

Process of approving examiners. Motion by McMillan that Examiner candidate must be approved by 70% of the Boat driving committee and then submitted to the board for approval. Cathy 2^{nd} .

Must the current examiners possess a class C rating to be able to give class c examination.? The feeling was that the examiner must possess at least the rating for which he / she is issuing an examination

Motion by Kurtis that Maintenance paperwork be submitted by January 15 of the following year to keep rating. Currently no requirement on deadline. Need deadline. 2nd Ruhl. Carried

Motion by committee that If tournament used to keep maintenance allow Chief Judge or Chief Safety director to sign off form 2nd by McCalmon Carried.

Motion to approve the Driving Sanction Form by Boat Driving Committee 2nd by McMillan Passed

When sanction form is turned in dates and site locations can be posted on the web site Tracy does safety and boat driving sanctions. Have Brian set up a hyperlink from NSSA

Elite Skiers: Chris Coupland presents report. Tom states purpose is to represent elite skiers. Athlete advisory committee. One meeting per year at HQ. Mission of committee USOC mandated committee. With NSSA not going to Olympics would this be a benefit NSSA.

How are alternates elected? Rich Taugner is alternate but is on the same team as Mark Massoglia

Motion by Skip that elite athlete not be from the same team 2^{nd} by Chris

Recommendation to change the alternate selection qualification for the next election.

clown/comedy

All clowns/comedy performing in more than waist deep water must have approved floatation.

Rules interpretation- for clown the original intent of the rule was for clowns/comedy being towed by motorized device.

2nd by Doug Schwenk. Carried- (get wording from Sherm)

10.05 paragraph 5. No action.

S-8.03 Protest procedures I-7.03 paragraph 1&2 for competitors 2nd by Cathy Luiting...Carried

6.05- Disqualificationexcept 6.04 11,12 2^{nd} by Roger carried.

National Records-

Procedure of establishing National Records

- 1. Application will be requested through USAWS HQ
- 2. A Completed application and "proof" will then be sent to the committee chair
- 3. The Committee will then review and either approve or disapprove record
- 4. If the record is approved, it will be brought before the BOD for full BOD approval.
- 5. Proof of the new record and the application will be sent to USAWS HQ for archival.

Pete Bonert not present but accounted for

TV production report- Terry Pasterski- The director has progressed in knowledge and has been learning show skiing. Every team should get some air time. Steve UPP has copy of video tape of show nationals.

103 different acts shown during the production. One team had only 3 acts shown. Too long focused on top of pyramid. Steve Upp indicates that the reason for extend close up shots was to enhance the personal component of the competition.

Wish list- better known network, 4th camera, Can the production be purchased for replay on public access? USAWS own the production. Cost of the time slot is large but USAWS gets the time through a partial barter. Generator failure was caused by LOC forgetting to refuel.

Marc Jackson speaks to the board Mike McCowan and Ryan Kindall do a good job to help get the production aired. Steve Upp also speaks to the board about the production. The show has to be compelling to a non skiing audience.

Skip suggests showing the tape in think tank and get feedback from the clubs at think tank. Chris asks the purpose of the production. Is the production grown oriented or just a "feel good" production for the teams. Steve Upp says it falls in line with the goals of USAWS. Show ski nationals is most expensive shoot due to the time and number of cameras necessary to put on a good show. Sponsors should be directed to USAWS, specifically Steve Upp.

Board discusses different possibilities of using the footage for other ventures to promote the ski club. Focus TV owns the footage. The total production cost was approximately \$50,000.00 Sunday afternoon at 5 PM (16 minutes of commercial time)

Report on Judges class- Scores are better overall things are improving. Class will be new in 2004. Regions need to set a time and place to have judges clinic.

Some of the Officials forms seem to be outdated Questionnaire being sent out to officials week of 11/09/03

Skip wants to talk about a system rating system We could get rated in up to 8 categories. Skip this is the dumbest idea. Sherm says the difference is in other sports.

Skip makes motion that we look into the possibility of having a rating system for judges 2^{nd} Doug Schwenk.

Carried Skip will work with officials committee

Discussion

Not a bad idea but teams are reluctant to vote Roger believes the return would be less than desirable Competitors are at a disadvantage because they cannot judge as many tournaments.

Scoring Method Pete Bonert- Teams like the new scoring method. Some concern about the announcing box score. Decision to go one more year.

Skip presents thought that the current system doesn't allow for voice tone, stage presence, humor, and general personality.

Some confusion that the proper forms were not being used. Issue corrected.

OLD Business-

Nationals for 2005- Division 1 Twin Lakes Aquanuts and Rock Aqua Jays.

Twin Lakes withdraws bid to use this to improve the site and work with the community so that their team can make it a better Nationals site. Board members would like Twin Lakes to put on a tournament prior to doing a Nationals

Joel Shapiro echoes board's appreciation to Twin Lakes for submitting a bid. Judging platform more to center, rip raff placed north of the show course. Some judges express appreciation for moving the sound booth to make the visibility better for the judges.

Motion by Doug to accept bid 2nd by Roger Carried.

Larry Presents bid for Waterhawks- goal is to keep the D2 Nationals growing. Dock Issue will be addressed and corrected.

Mark Poulos presents bid for Backwater Gamblers-2005

Site awarded to Backwater Gamblers Motion by Bruce to destroy the ballots 2nd by Roger carried

USAWS requires 18 YOA to take safety course. Since you have to be 18 YOA for the safety clinic, the same would hold true for boat driving. Gerry will check into reasoning for 18 year old requirement for safety clinic.

New Business

Nationals Awards- Garry Stout presents. Couple requested a swivel award in memory of Barbara Wolf who had a long history with water skiing. Nonetheless, Garry recommends recognizing those in ways other than special awards at the Nationals. Tom request variance from Robert's rules.

All National awards at D1 and D2 must have approval of the board to be accepted. 2nd by Gerry Luiting.

Skip withdraws motion and Gerry rescinds 2nd

Discussion:

Gerry- He had trepidation about giving the special award. If the board is going to give an award it could be cumbersome. Some of the teams want the special awards. It would be good for the board to set guidelines.

Larry – For thought, could those awards be for D2?

Bruce- We are at 6 awards now. Could we direct these efforts toward some other venue such as educational advancement to water skiing. It could have a bigger impact.

Ed- Do awards have to go through awards committee to get approval before being presented to the board?

Garry Stout recommends we rescind the Barbara Wolf award and not allow future awards. He feels giving out too many awards diminishes the importance of other awards.

Some disagreement

Cam – is giving out 14 awards too cumbersome?

Cathy feels there should be some criteria for notoriety for the awards.

Skip likes the endowment award. Feels the person giving the award should make at least a 5 year commitment.

Donna said from the point of a smaller team, getting the award is very important. Not likely to get one of the major 6 awards

Gerry Luiting- Some of the smaller teams have won the award categories. Doesn't believe it diminishes the Skip and Willa Cook award. Recommends sending it to committee to develop a clear and concise guide and policy.

Tom directs Gerry to take it to committee.

Roger Olson – Since his son passed Tim Olson scholarship award, it has been won by a female Carol Lowe runs it from AWSEF. Deadline date is April 01. 1500 a year scholarship. Roger indicates his appreciation for the contributions made toward the fund.

Tom – Wants to form an executive committee to handle issues between meetings. **Responsibilities-** can only handle business when the three are together and all decisions must be ratified by the board. If not ratified, then all efforts must be made to rescind
