

## 20<sup>th</sup> ANNUAL MIDWEST REGIONAL SHOW SKI TOURNAMENT JULY 30 & 31, 2011 – Cedar River, Cedar Rapids, IA


### We are planning on having Ellis Blvd closed to traffic for the tournament.

Due to our road closure **all traffic** should come to the showsite from Edgewood Rd NW and then onto Ellis Blvd, see maps below for suggested routes..

From hotels on Collins Rd (aka Hwy 100) and the I-380 area (north side of town). Go west on Collins Rd 1.5 mi to Edgewood Rd, then go south (left) 1.8 mi to Ellis Rd, then go east (left) 1 mi to Ellis Park. Parking will be available in Ellis Park.



From hotels on 33rd Ave SW & I-380 area (south side of town). Go north on I-380 1 mi to Wilson Ave, then go west (left) 2.4 mi to Edgewood Rd, then go north (right) 3.5 mi to Ellis Rd, then go east (right) 1 mi to Ellis Park.



Skier Parking will be available in Ellis Park (2200 Ellis Blvd), signs and personnel will direct you to the parking area. More directions will follow for equipment and boat trailer parking and boat launching.
