All other club participants shall meet with the Safety Director prior to their 20-minute set-up time. This meeting shall be at a location convenient for club members and no later than during the set-up period of the team preceding them. The exception to this would be the first team. There shall be an interval of at least ten minutes between the end of the meeting and the start of their set-up time. If not specified, the meeting will take place in the pre-staging area prior to the 20-minute set-up time.
