### Safety Meeting Schedule For Individual Competitors

#### All Swivel Open Competitors & Spotters

We will meet at 8:40 AM on the sidewalk by Main Starting Dock

#### Strap Doubles Competitors & Spotters

We will meet on the sidewalk by Main Starting Dock immediately following the last Swivel Open Competitors

#### Team Jump Competitors & Spotters

We will meet on the sidewalk by Main Starting Dock immediately following the last Strap Doubles Competitors

#### Freestyle Jump Competitors & Spotters

We will meet on the sidewalk by Main Starting Dock immediately following the last Team Jump Competitors

#### All Swivel 180 Competitors & Spotters

We will meet on the sidewalk by Main Starting Dock immediately following the last Freestyle Jump Competitor.

We will meet with all boat drivers of Swivel, Swivel Pairs & Strap Doubles at the back left dock once they have their boats in the water. Please ensure that your spotter has proper flotation and arrives on time.

Please ensure that all individuals and pairs are on time.

#### **NSSA Rule:**

11.09 Required Safety Meeting - All competing club boat personnel, Safety Director, and show director/chairman shall meet with the tournament Safety Director and Chief Judge prior to each team's performance. Boat personnel who are also, skiers have the option of having their meeting with the Safety Director immediately following their team's safety meeting. The sponsor shall state the time and place in the tournament announcements. All other club participants shall meet with the Safety Director prior to their 20-minute set-up time.

This meeting shall be at a location convenient for club members and no later than during the set-up period of the team preceding them. The exception to this would be the first team. There shall be an interval of at least ten minutes between the end of the meeting and the start of their set-up time. If not specified, the meeting will take place in the pre-staging area prior to the 20-minute set-up time.

#### **INDIVIDUAL & SHOW ACTS COMPETITION RULES**

10.09 Required Safety Meeting - All competing personnel shall meet with the tournament Safety Director and Chief Judge prior to the start of that day's competition. The sponsor shall state the time and place in the tournament announcements. Failure of competitor to be present at the meeting will result with a penalty of 50% of the entry fee for that Tournament.
