

INDIVIDUAL ENTRY REQUIREMENTS & INSTRUCTIONS

- Review your act instructions below before starting.
- Entry & Additional Paperwork Submission requires uploads for athletes, drivers, pinners, and boat documentation. All documents must be ready before starting (you cannot save midway through).
- **ALL expiration dates** must be valid through **July 27, 2026**, or later.
- Incomplete or late submissions: 50% late fee + seeded first in your division.
- Individual competition is limited to 70 entries. If full, no late entries will be accepted.

APPLIES TO: TEAM JUMP

REQUIRED SAFETY MEETINGS

- A safety meeting is required for each act. The schedule will be posted closer to the tournament date.
- Competitors, drivers, pinner, and announcers must attend the safety meeting and must be on time.
- Missing the meeting = not eligible to ski/participate.

TOURNAMENT DELAY

If the Individuals' tournament does not finish on Friday:

- Resumes Saturday after the last team.
- Continues Sunday, if needed, after the last team.

IF CHANGES ARE MADE AFTER ONLINE SUBMISSION

- **If changes are required**, email tournamentfiles@gmail.com immediately for instructions.
- **If no changes:** Paperwork will be printed, and music will be distributed.
- **If revisions cannot be made before printing**, you must bring printed copies to the registration table on **Friday, July 24, between 6:15 AM - 6:30 AM.**

Required at Registration (if applicable):

- **Swivel & Doubles:** Pass List (15 copies)
- Music file (USB only), labeled with competitor name and act/division
- Competitor USA-WSWS membership card (1 copy)
- Driver verification (1 copy of each required document), if not using a tournament driver
- Pinner USA-WSWS membership card (1 copy), no tournament pinner provided
- Boat verification (1 copy of each required document), if not using the tournament boat or team boat
- Announcer's Form (1 copy)
